RESOLUTION APPROVING TEMPORARY EASEMENT BETWEEN ADAMS COUNTY AND E-470 PUBLIC HIGHWAY AUTHORITY

WHEREAS, in August 2022, Adams County entered into an Intergovernmental Agreement ("IGA") with E-470 Public Highway Authority and City of Brighton, to construct an interchange at the intersection of E-470 and Sable Boulevard, within the City of Brighton, County of Adams ("Project") approved in Resolution 2022-434; and,

WHEREAS, under the terms of the IGA, the Project requires the relocation of an existing trail to the south of its current location in order to accommodate the new on-ramp from Sable Blvd to southbound E-470; and,

WHEREAS, the existing trail is located on a portion of Adams County property, identified as Parcel ID# 0156931101001 ("Parcel") of the Adams County Assessor records; and,

WHEREAS, a Temporary Easement is required by Adams County to relocate the existing trail to the new trail location, as depicted in Exhibit B of the Temporary Easement; and,

WHEREAS, E-470 Public Highway Authority and wishes to obtain a Temporary Easement on the Parcel to relocate the existing trail under the terms and conditions of the attached Temporary Easement.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners, County of Adams, State of Colorado, that the attached Permanent Fence Easement between Adams County and Allied Waste Transportation, Inc., a copy of which is attached hereto and incorporated herein by this reference, be and hereby is approved.

BE IT FURTHER RESOLVED that the Chair of the Board of County Commissioners is hereby authorized to execute said Permanent Fence Easement on behalf of Adams County.
